Reserve Bank of India Act, 1934 - Issue of a
certificate of registration to your company.

Please refer to your application dated 04.07.1997 for a certificate of registration under Section 45-IA of the Reserve Bank of India Act, 1934, to carry on the business of a non-banking financial institution and further correspondence with your company resting with your letter No. NIL dated 17.02.1998. On the basis of the information/data furnished in the application and in the correspondence, the Reserve Bank is pleased to, issue a certificate of registration to your company and we enclose certificate No.14.00074 dated 26.2.1998 permitting your company to carry on business of a non-banking financial institution. The certificate of registration is subject to your company complying with the following terms and conditions:-

- i) The company shall not raise public deposits.
- ii) As and when your company desires to raise public deposits, it should obtain Reserve Bank of India's prior approval after obtaining minimum 'Investment Grade' credit rating from an Approved Credit Rating Agency.
- iii) A certified copy of the Certificate of Registration shall be kept displayed at the Registered Office and other offices / branches, if any, of the company.
- iv) While displaying the copy of the certificate, both sides thereof may be exhibited.
- v) If it is desired to indicate directly or indirectly in any advertisement that the permission of the Reserve Bank of India has been obtained by your company for carrying on the business as a non-banking financial institution, the following words shall be used:

"A certificate of registration to carry on the business of a non-banking financial institution has been obtained from the Reserve Bank of India in terms of Section 45-IA of the Reserve Bank of India Act, 1934. It must be distinctly understood, however, that in issuing the certificate of registration, Reserve Bank of India does not undertake any responsibility for the financial soundness of the company or for the correctness of any statements made or any commitments made or opinions expressed."
